Community meetings conducted or scheduled:

In the past 20 months, U.S. Attorney John Suthers has made 86 public appearances to speak about the domestic war on terrorism, including the Patriot Act. He has spoken to over 30 service clubs and over 30 law enforcement groups. The remaining groups have been bar association groups, business groups, teachers and law students. He has a Power Point that he has given on many such occasions. Mr. Suthers has debated the ACLU on approximately a dozen occasions about the Patriot Act. He has done a television debate on the Patriot Act and done a half dozen newspaper interviews concerning it.

Since the initiative was announced Mr. Suthers has scheduled the following events:

 Wyoming on the Patriot Act.
- 5. September 18 Speech to a women's group in Canon City, Colorado on the Patriot Act, as well as radio appearance and interview with editorial board in Canon City.
