- The INS runs approximately 20,000 Domestic searches per month using the domestic Choicpoint contract.
- We estimate International volume to be approximately 15% of Domestic volume since this is for the QRT's and Investigations.
- Estimated cost of an International search is approximately \$50 (assuming 80-90% Mexican searches).

#### Introduction:

The purpose of this document is to provide the U.S. Immigration and Naturalization Service (INS) with a detailed description of ChoicePoint's international data capabilities, and a statement of work for providing access to international data services. Presently, ChoicePoint maintains citizen and business data from Mexico, Colombia, Costa Rica, Brazil, and Argentina, and is actively seeking to add data from other countries in Latin America, Asia, and Europe. Presently, ChoicePoint is the only provider of online international data on both individuals and businesses, including citizen registries in several Latin American countries.

#### **ChoicePoint Overview:**

ChoicePoint has been providing information to support customer business decisions since 1899, when Equifax insurance Services was founded. Originally focused solely on the insurance industry, ChoicePoint's predecessors leveraged information-gathering competencies to provide critical data to the commercial sector, government agencies, legal firms, healthcare organizations, and many other types of organizations.

In 1997, the current ChoicePoint management team, led by Chairman and Chief Executive Officer Derek Smith, spun off from Equifax to create an independent, publicly traded organization. Since the spinoff, ChoicePoint has acquired more than 20 companies in an effort to augment our information gathering and dissemination capabilities. Today ChoicePoint is the nation's largest provider of online and on-demand public records, maintaining databases with more than 13 billion domestic and international online public records, and managing a staff of more than 1,500 researchers who obtain public record information from courthouses and other public sources on a daily basis. Additionally, partnerships extend our reach into Latin America, Europe, and the Pacific Rim. More than 5,000 employees in locations in all parts of the United States helped ChoicePoint generate over \$593 million in revenues in 2000.

ChoicePoint expanded its data collection efforts in 2000 to include international data to complement its U.S. public record products. Since then, ChoicePoint has added significant international data assets through acquisitions, direct relationships with various foreign governments, and by expanding its international network of trusted data vendors. ChoicePoint places a heavy emphasis on data accuracy and timeliness, and goes to great lengths to verify that the data offered in ChoicePoint products is being acquired legally from official sources. In cases where ChoicePoint utilizes a third party vendor as a data source, the vendor warrants to ChoicePoint that they have obtained the data legally, that they have the right to sell the data to ChoicePoint, and that they have not in any way violated the Foreign Corrupt Practices Act.

#### Mexico

### CITIZEN REGISTRY

Nationwide listing of all Mexican citizens registered to vote as of the 2000 national election - updated annually. Data includes full name(s), legal addresses, DOB, Place of Birth, Gender, and identification information (RFC Number).

### **DRIVERS' LICENSES**

Database contains only licenses issued in Mexico City since 1997, and is updated monthly. Data includes full name(s), address, RFC/Tax ID/License Number, license class, DOB, Gender, occupation, and telephone number.

### VEHICLE IDENTIFICATION (VIN)

Database contains Title and Registration information on vehicles registered in Mexico City and is updated monthly. Data includes full name(s), address, RFC/Tax ID/License Number, DOB, Gender, telephone number, year, class, make, model, tag number, serial number, engine markings, and status.

### BIG COMPANIES AND MANAGERS

Encompasses about 90% of all major corporations operating in Mexico, with descriptive information on line of business, full address, telephone and FAX numbers, key manager and executive names, personal and professional e-mail addresses, level of capitalization, and number of years in business information. We also include historical back to 1999. Descriptive information in both English

Nationwide listings for business & residential (including FAX numbers), with business classification data in English and Spanish and full address information.

#### AIRCRAFT

Nationwide registry of aircraft, including tall identifiers, type of aircraft, name of owner, updated semi-annually.

CITIZEN REGISTRY (SCHEDULED TO BE ADDED SEPTEMBER 2001)
National registry file of all adult Colombians, including date and place of birth, gender, parentage, physical description, marital status, registration date, registration and passport number, and registered profession. Includes approximately 31 million Colombians now alive, as well as death records since 1991.

#### Costa Rica

#### CITIZEN REGISTRY

Monthly update of passport and national identification of all Costa Rican citizens. Data includes full name(s), gender, National ID/Passport number, ID expiration date, and country of citizenship.

#### COMPANY OWNERS

Registry data for owners of businesses which do business in the State of São Paulo, which includes about 80% of all Brazillan businesses. Updated annually. Data includes name of business, form of incorporation, trade names, tax id (CNPJ/CPF) of both business and investor, investor name, investor gender, investor address, investor nationality, investor's national ID card ("cédula"), investor's capital at risk, description of business in Portuguese and English.

#### PRIVATE COMPANIES

#### EXPORTS AND IMPORTS

Database of transaction records of Brazillan foreign trade, database identifies Brazillan parties to exports or imports, country of destination or origin, product and value sold, approximate dates. Historical data back to 1994. Updated semi-annually. Descriptive data in English.

#### MAJOR TELEPHONE LISTINGS

Major cities' telephone listings, residential and businesses.

#### Proposal to INS:

ChoicePoint proposes providing a subscription for unlimited, dedicated access to all data sets described above to the INS at the flat rate of \$1.0 million for the period September 20, 2001 through September 30, 2002. In consideration of this monthly flat rate, USG will receive the following:

- Unlimited number of user identification codes for INS Quick Response Team (QRT) and intelligence divisione. エンピイナ・Cーナーのへ
- Ability to perform unlimited number of searches against all data sets currently available.
- Cloaked access to data ChoicePoint will have no ability to view any transactions performed by INS personnel, and no ability to recreate or otherwise investigate subjects of searches performed by INS personnel.

Pricing in future years is subject to change based upon the availability of new data sets accessed by INS and any other changes in INS requirements.
