As announced on February 2, 2016, we have reached agreement with the European Commission on the EU-US Privacy Shield and are working now to finalize the agreement documentation. Therefore, the record that you have requested does not exist. Under the FOIA, the Department has no obligation to create, compile, or obtain from outside the Department a record to satisfy a request (15 C.F.R. § 4.3(b)).

In addition, you sought expedited processing of your request. The requirements for requestors seeking expedited processing can be found at 15 C.F.R. § 4.6(e)(1). Because the record that you requested does not exist, we are denying your request for expedited process. Please note that the Department has provided you a final response within ten calendar days.

In accordance with 15 C.F.R. §§ 4.10(a) and (b), you have the right to appeal this determination within 30 calendar days from the date of this letter. The Department deems written or electronic appeals arriving after normal business hours (8:30 a.m. to 5:00 p.m., Eastern Time, Monday through Friday) as received on the next normal business day.
